### Booking Terms and Conditions

1. **WHO IS RESPONSIBLE:** The person signing the booking form is assumed to have full authority of all the people listed on the booking form and so accepts the terms and conditions herewith on behalf of all those named.
2. **TARIFFS:** The tariff shown on all publications is guaranteed from the date we receive your deposit.
3. **RESERVATION:** Your booking will be reserved upon receipt of the completed booking form and deposit. Confirmation of payment will be sent with details of how and when to pay the balance.
4. **DEPOSIT:** A deposit of at least 50% of the cost should be sent with the completed booking form to MICK BOWMAN. Cheques should be made payable to "G T Fisheries". The deposit is non refundable. If a booking is made within 10 weeks of the departure date, the full balance is payable.
5. **BALANCE OF PAYMENT:** The balance must be paid in full at least 10 weeks before commencement of your trip. If the balance is not received 10 weeks before departure, we reserve the right to cancel the booking. When we receive the full payment, we will send confirmation of payment and details of your trip.
